Our program aims to remove barriers that prevent children from accessing and advancing in their musical aspirations.


# Our Most Robust Year Yet!

We expanded instructional opportunities, and students chose to enroll in more programs across the year.



In the last year, Crescendo Phoenixville has experienced its most robust year yet—nearly doubling student engagements while deepening the quality of instruction across all program areas.









# **Growth Across Every Program**

#### After-School Program @ Barkley

- Grew from 28 to 32 students (+14%)
- Hired teaching artist, Emily McDonald, improving student-teacher ratio and individual support

#### **Classic Cinema Project**

- Expanded from 16 students in 2024 to 26 students in 2025, (+63%)
- Maintained a 3:1 student-to-instructor ratio
- Culminated in a student-written, student-scored film performed live at the Colonial Theatre
- Facilitated by Dr. Jennifer Fleeger, a full professor of film history at Ursinus College and accomplished violinist, whose expertise in both film and music enriches Crescendo's interdisciplinary projects.

#### **Summer Program 2024**

- Expanded from 2 weeks to 4 weeks of camp in 2024
- Grew from 12 24 students doubling participation over prior years
- 2025 enrollment is expect to remain steady at these levels.

#### **Half-Day Intensive Clinics (New!)**

- 1/2 Day Intensive Music Clinic in partnership with the Pennsylvania Philharmonic, funded by the Justamere Foundation.
- Reached 34 students across nine school half-days with average 21 students participating each month.
- Small classes and individual lessons taught by professional PA Philharmonic musicians.

#### **Crescendo Camerata (New!)**

- Chamber music pilot program for older beginners (viola, cello, violin), funded by the Presser Foundation
- Served 4 students with a 2:1 student-to-mentor ratio


At Crescendo, our teaching artists are musicians who are also out performing—bringing their artistry into the learning experience.





# **Financial Overview (2024)**






**2024 Funding Sources**

# CRESCENDO PHOENIXVILLE NOTES TO FINANCIAL STATEMENTS

#### NOTE A - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Nature of Activities and Reporting Entity

Crescendo Phoenixville, (the Organization), a Pennsylvania nonprofit located in Phoenixville, Pennsylvania, is a community based program that offers high-quality violin education to children in Phoenixville. The Organization's mission is to work to eliminate barriers that prevent children from accessing and advancing in their musical aspiration by providing free violins, year-round group instruction and performance opportunities.

#### **Basis of Accounting**

The financial statements of the Organization have been prepared on the cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the cash basis, the only asset recognized is cash, and no liabilities are recognized. All transactions are recognized as either cash receipts or disbursements, and noncash transactions are not recognized.

#### **Functional Expense Allocation**

The costs of providing program and other activities have been summarized on a functional basis in the statement of functional expenses – cash basis. Accordingly, certain costs have been allocated among program services and supporting services benefitted. Such allocations are determined by management on an equitable basis.

#### Income Taxes

The Organization is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code and therefore has made no provision for federal income taxes in the accompanying financial statements. In addition, the Organization has been classified as an organization other than a private foundation within the meaning of Section 509(a) of the Internal Revenue Code and therefore they are not subject to excise tax on investment income.

The Organization files annual information returns as required which are subject to examination by the Internal Revenue Service and other taxing authorities generally for three years after the returns have been filed.

#### Subsequent Events

In preparing these financial statements, the Organization has evaluated events and transactions for potential recognition or disclosure through April 24, 2025, the date the financial statements were available to be issued.
